Sub : CGST- Jurisdiction of Chief Commissioner of Central Tax and Principal Commissioner / Commissioner / Additional Commissioner of Central Tax under the Central Goods & Services Act, 2017 and the jurisdiction of the Commissionerates in the Pune Zone including the state of Goa with effect from 22.06.2017- Notification No. 2/2017- Central Tax dated 19.06.2017- reg

The taxpayers/ trade are hereby informed that the Government of India vide Notification No. 2/2017-Central Tax, dated 19.06.2017 has notified the territorial jurisdictions of the respective Principal Chief Commissioner/Chief Commissioner/Principal Commissioner/ Commissioner of Central Tax, Commissioner of Central Tax (Appeals), Additional Commissioner of Central Tax (Appeals) and Commissioner of Central Tax (Audit) and the said notification shall come into force on 22.06.2017.

2. Consequent upon the above said Notification, the Pune Central Tax Zone will be headed by the Chief Commissioner of Central Tax, Pune and will comprise of the following Commissionerates.

(i) Pune-I	(vi) Audit-II, Pune
(ii) Pune -II	(vii)Appeals-I, Pune
(iii)Kolhapur	(viii)Appeals-II, Pune
(iv) Goa	(ix)Appeals, Goa
(v) Audit-I, Pune	

3. The jurisdiction of the Central Tax Commissionerates, Divisions and Ranges of the respective Commissionerates viz., Pune- I, Pune-II, Kolhapur & Goa Central Tax Commissionerates, Audit-I Pune , Audit-II Pune Central Tax Commissionerates and Appeals-I Pune, Appeals-II Pune and Appeals, Goa Central Tax Commissionerate are detailed as per Annexure- I.

4. The PIN codes as mentioned in the column of jurisdiction (PIN Code wise) in the Annexure-I in the state of Maharashtra and Goa have been taken on the basis of PIN Codes of the Indian Postal Authority.

5. The Jurisdiction of the Commissionerates will include any other newly created PIN Codes, by the Postal Authority, contiguous to the nearest PIN Code in the jurisdiction.

7. In case of a newly created PIN Code by the Postal Authority falling under the jurisdiction of two or more Commissionerates, the area of the said PIN Code will be covered under the jurisdiction of the Commissionerates having the largest share of the newly created PIN Code area.

8. The taxpayers / trade are requested to carefully note the changes in the jurisdiction of the Commissionerates/Divisions/Ranges/Circles. All the members of the Regional Advisory Committee and Trade Associations, Chambers of Commerce in the Pune Zone are requested to circulate this Trade Notice among their constituent members for information and guidance.

This Trade Notice shall come into effect on 22.06.2017.
